Review of Operations

Exploration and Development of Coal Mining Activities

As announced on 26 June 2013, APAC Coal Limited ("APAC") and majority shareholder Magnus Energy Group Ltd ("Magnus"), Magnus wholly owned subsidiary Antig Investments Pte Ltd and APAC (collectively referred to as "Group") has issued a Notice of Intent to Resolve Investment dispute through Consultations and Negotiations to the Government of the Republic of Indonesia.

The purpose of the action taken by the Group is to seek recourse under the Agreement between the Government of the Republic of Singapore and the Government of the Republic of Indonesia on the Promotion and Protection of Investments and the Agreement between the Government of Australia and the Government of the Republic of Indonesia concerning the Promotion and Protection of Investments.

APAC is now within the 6 months waiting period for the Indonesian authorities to response to our Letter of Intent to Resolve Investment Dispute through Consultations and Negotiations under the Business Investment Treaty on the Promotion and Protection of Investments.

The above development may have a material impact upon the Group, and APAC will make further announcement(s) as and when there are material developments in relation to the aforesaid matter.
