The Scheme was overwhelmingly approved by shareholders at the Extraordinary General Meeting held on 3 December 2013.

Brambles intends to lodge a copy of the orders made by the Federal Court of Australia with the Australian Securities and Investments Commission on 9 December 2013 and the Scheme will become effective on that date.

Recall is expected to commence trading on the ASX on Tuesday, 10 December 2013 under the ASX code "REC", initially on a deferred settlement basis. Brambles will trade on an ex-entitlements basis from Tuesday, 10 December 2013. The Demerger is expected to be implemented on Wednesday, 18 December 2013.
