## **DECMIL GROUP LIMITED AWARDED SECOND MAJOR MANUS ISLAND CONTRACT**

**Key points:**

- **\$147 million contract for the construction of expansion of Offshore Processing Centre on Manus, PNG for the Department of Immigration and Border Protection**
- **Follows July 2013 contract to construct processing centre on Manus Island**
- **Further expands building and infrastructure experience in remote and offshore locations**

Decmil Group Limited (ASX:DCG) has been awarded a second contract to design and build an expansion of the offshore processing centre at Lombrum, Manus Island in Papua New Guinea (MOPC Lombrum).

The \$147 million project comes just five months after Decmil Group's wholly-owned subsidiary Decmil Australia won a \$137 million contract to construct a major facility on the island.

The contract at MOPC Lombrum will include:

- accommodation facility for transferees
- accommodation facility for staff
- central dining and recreational facilities to cater for transferees and staff
- central catering health, welfare and operational/logistics facilities to cater for all services provider staff, transferees and other site occupants, and
- supporting engineering facilities and services.

Decmil Australia has commenced work on the project and is currently working with the Australian Government to finalise scope of works and associated timing.

Decmil CEO Scott Criddle said: “This second win on Manus Island demonstrates our proven capability to work on government projects and showcases our expertise in delivering buildings and infrastructure in offshore and remote locations.

“The contract expands our scope of works on Manus Island which is in addition to the existing \$137 million contract for the Manus Island Offshore Processing centre at Lorengau (MOPC) awarded in July 2013.

“The win strengthens our diversification strategy away from reliance on the resources and oil & gas industries.

“Our proven delivery coupled with our strong relationship with the Department of Immigration and Border Protection has enabled us to achieve this significant win,” Mr Criddle said.
