### Message:

NZX announces changes to the NZX 15 Index following the March 2014 Quarterly Index Review. The changes below, and the monthly index rebalance, will be effective at market open on Monday 24 March 2014.

Chorus Limited (CNU) will be removed from the NZX 15 Index at the March 2014 Quarterly Index rebalance, as a result of failing to satisfy ranking criteria for continued inclusion. Kiwi Income Property Trust (KIP) will be added to the NZX 15 Index at the March 2014 Quarterly Index rebalance, in place of CNU, as the highest ranked non-constituent having also met the liquidity requirements for inclusion.
