## Appendix 5B

We refer to your letter dated 5 August 2014 in regard to Leopard Resources NL's ("the Company") Appendix 5B for the quarter ended 30 June 2014 and comment as follows:

1. *It is possible to conclude on the basis of the information provided that if the Company were to continue to expend cash at the rate for the month indicated by the Appendix 5B, the Company may not have sufficient cash to fund its activities. Is this the case, or are there other factors that should be taken into account in assessing the Company's position?*

On 13 June the Company announced the successful placement of 100 million shares using its capacity under prior approval given by shareholders in the general meeting in March this year. In its quarterly activity statement for the June 2014 quarter the Company reiterated that point, and stated that it continues to look for further funding. The Company confirms that it continues discussions to raise capital.

As such, the Company confirms that it has sufficient cash and other sources of funds to fund its ongoing activities.

2. *Does the Company expect that in the future it will have negative operating cash flows similar to that reported in the Appendix 5B for the quarter and, if so, what steps has it taken to ensure that it has sufficient funds in order to continue its operations at that rate?*

The Company expects to continue to have future negative cash flows for the foreseeable future as is normal for a resource company conducting exploration activities. As outlined in 1. above the Company has sufficient financial resources to fund its current level of activities.

The Company continues to monitor its cash and funding requirements.

3. *What steps has the Company taken, or what steps does it propose to take, to enable it to continue to meet its business objectives?*

With the balance of cash and other financial resources available, the Company is of the opinion that it is in a position to continue to meet its business objectives and to fund its minimum expenditure commitments. As part of its internal processes, the Company continually reviews its

commitments and in the event that additional funds are required, the Company will actively pursue further fund raising initiatives.

4. *Can the Company confirm that it is in compliance with the listing rules, and in particular, listing rule 3.1?*

The Company is in compliance with the listing rules, and in particular, listing rule 3.1.

5. *Please comment on the Company's compliance with listing rule 12.2, with reference to the matters discussed in the note to the rule.*

Having given consideration to the composition of the balance sheet, relative size of liabilities to assets and access to funds the Company confirms that it is in compliance with listing rule 12.2, for the reasons as outlined above, and further that the Company:

- (a) has sufficient financial resources in cash and receivables to meet its current activities;
- (b) has reasonable expectation that it will be able to fund its planned future activities; and
- (c) will pursue access to further funding, should there be a requirement.

**Leopard Resources NL ("Company")**

I refer to the Company's Quarterly Report in the form of Appendix 5B for the period ended 30 June 2014, released to ASX Limited ("ASX") on 1 August 2014, (the "Appendix 5B").

ASX notes that the Company has reported the following.

1. Receipts from product sales of nil.
2. Net negative operating cash flows for the quarter of \$123,000.
3. Cash at end of quarter of \$42,000

In light of the information contained in the Appendix 5B, please respond to each of the following questions.

1. 5. Please comment on the Company's compliance with listing rule 12.2, with reference to the matters discussed in the note to the rule.

### **Listing Rule 3.1**

If you are unable to respond by the time requested you should consider a request for a trading halt in the Company's securities.
