### Challenger Limited (ASX Code: CGF) Request for Trading Halt

Challenger Limited (ABN 85 106 842 371) (CGF) requests that an immediate trading halt be granted by the Australian Securities Exchange (ASX) with respect to its ordinary shares.

The trading halt is necessary as CGF proposes to conduct an underwritten institutional placement of ordinary shares (**Placement**) to raise up to A\$250m. CGF intends to use the proceeds from the capital raising to fund expected future growth.

CGF will make an announcement to the market today containing further details of the Placement.

CGF wishes the trading halt to last until such time as it is in a position to make, and makes, an announcement to the market regarding the pricing of the Placement. It is expected that the bookbuild for the Placement will be completed by the commencement of normal trading on 21 August 2014 at which time CGF will make an announcement to the market.

CGF is not aware of any reason why the trading halt should not be granted, nor is it aware of any other information required to be provided to the market or ASX in relation to the trading halt.
