Drillsearch's Offer for Ambassador and Broker Handling Fees

Drillsearch has a relevant interest in 85.57% of Ambassador and encourages all remaining Ambassador shareholders to **ACCEPT** the Offer **NOW**, as the Offer is currently due to close at 7pm (Sydney time) on 8 September 2014.

Drillsearch will pay a commission or broker handling fee to brokers who solicit acceptances of the Drillsearch Offer from their retail clients (refer below and to the Third Supplementary Bidder's Statement attached for further details).

Drillsearch encourages Ambassador shareholders to ACCEPT NOW as:

- Drillsearch controls Ambassador and the Ambassador Board
- The Independent Director of Ambassador has accepted the Drillsearch Offer for his own shares
- Drillsearch has a relevant interest in 85.57% of Ambassador and intends to proceed to compulsory acquisition if it acquires 90%
- Ambassador shareholders will receive their consideration within 10 Business Days by accepting the Drillsearch Offer. It may be some months before consideration is provided under compulsory acquisition
- The Drillsearch Offer represents an attractive premium of 67.1% over Ambassador's unaffected share price¹

Broker Handling Fees

Drillsearch will pay a handling fee ("**Handling Fee**") to share brokers in respect of valid acceptances received from eligible Ambassador Shareholders ("**Acceptances**"), where such Acceptances are from clients of the broker and were procured by the broker. An eligible Ambassador shareholder is one who is not a broker or an associate of a broker and holds less than \$300,000 of Ambassador shares.

The Handling Fee will be 0.75% of the consideration payable by Drillsearch under the Drillsearch Offer to the accepting shareholder subject to a minimum payment of \$50 and a maximum payment of \$750 per acceptance.

The Handling Fee is payable to brokers only in respect of acceptances of the Offer that they solicit from their clients. 1. **INTRODUCTION**

This document is the third supplementary bidder's statement ("Third Supplement") to the Bidder's Statement dated 12 June 2014 ("Bidder's Statement") as supplemented by the first supplementary bidder's statement dated 16 June 2014 ("First Supplement") and the second supplementary bidder's statement dated 1 August 2014 ("Second Supplement") made under section 643 of the *Corporations Act 2001* (Cth) (the "Act)" and the notices of variation dated 9 July 2014, 16 July 2014 and 25 July 2014 made under section 650D of the Act.

The Third Supplement is issued by Drillsearch (Central) Pty Limited ABN 41 160 522 056 ("Drillsearch Bidco") a wholly-owned subsidiary of Drillsearch Energy Limited ABN 73 006 474 844 ("Drillsearch") in relation to its off-market takeover bid by Drillsearch Bidco for all of the ordinary shares in Ambassador Oil and Gas Limited ABN 28 152 595 429 ("Ambassador") that it does not already own ("Offer"). This Third Supplement supplements, and must be read together with, the Bidder's Statement, the First Supplement and the Second Supplement.

Unless the context requires otherwise, terms defined in the Bidder's Statement, First Supplement and the Second Supplement have the same meaning in this Third Supplement. This Third Supplement prevails to the extent of any inconsistency with the Bidder's Statement, First Supplement and Second Supplement.

A copy of this Third Supplement was lodged with the Australian Securities and Investments Commission ("**ASIC**") on 4 September 2014. Neither ASIC nor any of its officers takes any responsibility for the contents of this Third Supplement.

2. **BROKER HANDLING FEES**

2.1 Overview

Subject to the conditions set out below, Drillsearch Bidco will pay a handling fee ("Handling Fee") to a share broker and participant in CHESS ("Broker") in respect of valid acceptances received from retail Ambassador Shareholders ("Acceptances"), where such Acceptances are from clients of the Broker and were procured by the Broker.

A retail Ambassador Shareholder is one who is not a Broker or an associate of a Broker and who is, at the date of receipt of the Acceptance, recorded on the Register as holding less than \$300,000 of Ambassador Shares.

The Handling Fee will be 0.75% of the Offer Consideration payable by Drillsearch Bidco under the Drillsearch Offer as a result of that Acceptance subject to:

- (a) the minimum Handling Fee payable in respect of any Acceptance being \$50 (excluding GST); and
- (b) the maximum Handling Fee payable in respect of any Acceptance being \$750 (excluding GST).

The value of the Drillsearch scrip component of the Offer Consideration will be calculated based on the closing price of Drillsearch Shares on the ASX on the last trading day of the Offer Period.

The Handling Fee will not be increased.

To qualify for the Handling Fee, the Acceptances must be received by Link Market Services Limited (the "**Registry"**) after the date of this Third Supplement and before the end of the Offer Period. Set out below are further conditions attaching to the offer of a Handling Fee:

- (a) the submission of any acceptance bearing a Broker's official stamp will constitute an acknowledgment by the relevant Broker that it has represented to Drillsearch Bidco that:
 - (i) neither it nor an associate of it is the accepting Ambassador Shareholder;
 - (ii) the Handling Fee will not be shared directly or indirectly with the accepting Ambassador Shareholder;
 - (iii) it and the accepting Ambassador Shareholder are not associated for any other reason under the Corporations Act; and
 - (iv) if requested, the Broker will confirm the above in writing to Drillsearch Bidco before the Handling Fee is paid;
- (b) for Ambassador Shareholders on the CHESS subregister, where that Ambassador Shareholder directly requests Drillsearch Bidco (and not the relevant Broker) to initiate acceptance of the Drillsearch Offer on their behalf, that Broker will not be entitled to receive the Handling Fee;
- (c) no Handling Fee is payable in respect of Acceptances which are withdrawn pursuant to the Corporations Act or which are not treated as a valid Acceptance by Drillsearch Bidco; and
- (d) the Handling Fee is for retail acceptances only. Drillsearch Bidco reserves the right at its absolute discretion not to pay Handling Fees on acceptances it deems to be from the same Ambassador Shareholder, non-retail Ambassador Shareholders or acceptances that appear to have been split or otherwise structured to take advantage of the Handling Fees. Further, Drillsearch Bidco reserves the right in its absolute discretion not to pay Handling Fees in any other circumstances as determined by it.

2.2 Payment

The Handling Fee will be payable to any Broker who submits to the Registry:

- (a) a valid and duly completed claim form ("Claim Form") which sets out:
 - (i) the Broker's Participant Identification Number; and
 - (ii) a representation that neither the Broker nor its associate is the accepting Ambassador Shareholder and that the fee will not be passed on or otherwise shared directly or indirectly with the accepting Ambassador Shareholder; and
- (b) a list of Acceptances ("Acceptance List") which contains:
 - (i) the registered name and address for each Ambassador Shareholder to which the Claim Form relates;
 - (ii) the Holder Identification Number for each Ambassador Shareholder to which the Claim Form relates; and
 - (iii) the number of Ambassador Shares in respect of which each such Ambassador Shareholder has accepted the Drillsearch Offer and the date of the relevant Acceptance(s); and
- (c) if the Acceptance(s) were effected by an Acceptance Form, a copy of such form bearing the Broker's stamp,

such that they are received by the Registry in the formats described below by 7:00pm (Sydney time) on the day which is 5 Business Days after the end of the Offer Period and thereafter provides satisfactory evidence reasonably requested by the Registry that such Acceptance(s) meet the requirements of the Handling Fee.
