Financial

At 31 December 2014 the Company held \$286,000 in cash reserves.

Canegrass Project

Preliminary metallurgical assessment and initial flowsheet development for the Canegrass Project continues to progress and is expected to take between six months and a year.

Further evaluation of the Project during the quarter has determined that due to the change in JORC there is not a 2014 compliant JORC resource, additional work will need to be undertaken in the coming months to determine if a resource exists.

Having completed a program of works study during the quarter ended 30 September 2014, the Company continues to address areas of potential problems identified in the study. Nickelore continues to seek to significantly reduce the capital cost of the Project. While the final operation is unlikely to be on the scale originally envisaged, Nickelore believes the end result will be profitable and viable over the long term and justify the continuing faith of its shareholders.

Other

The Board continues to review investment opportunities in commodity sectors and jurisdictions that have the potential to significantly add value for shareholders.
