JIM CLAYTON BIOGRAPHY

Fixed Remuneration	\$800,000 per annum, inclusive of superannuation contributions.
Short Term Incentive (STI)	Participation in Breville's annual STI Plan.
	The maximum STI opportunity is 70% of Fixed Remuneration.
Long Term Incentive (LTI)	Participation in Breville's annual LTI Plan.
	The LTI for the 12 month period commencing 1 July 2015 shall be performance rights to be issued under Breville's LTI Plan totalling \$400,000, with half of these performance rights vesting if Mr Clayton has not:
	 a) terminated his employment (other than in circumstances of death or total permanent incapacity); or
	 b) had his employment terminated by Breville summarily,
	before 31 December 2018.
	The other half of these performance rights will vest if the performance conditions set out in the invitation to be issued relating to these performance rights are satisfied.
Notice Period	6 months by either Breville or Mr Clayton.
	Nil by Breville in the case of material breach or serious misconduct by Mr Clayton.
Termination Payment	6 months' Fixed Remuneration, other than in the case of material breach or serious misconduct by Mr Clayton.
	Treatment of any STI and LTI benefits on termination will be determined in accordance with the rules of those plans.
Post-Employment Restraint	A 12 month restraint, with Mr Clayton being paid 50% of his Fixed Remuneration (at that time) during the restraint period, until such time as Mr Clayton has obtained full time employment (or equivalent consultancy) with another party, which is not in breach of his restraint.
