On 11 February 2015, the Director of Atlantic's wholly-owned subsidiaries Atlantic Vanadium Holdings Pty Ltd (Administrators Appointed)(Receivers and Managers Appointed) and Midwest Vanadium Pty Ltd (Administrators Appointed)(Receivers and Managers Appointed) appointed administrators and the senior secured note holders subsequently appointed receivers (refer ASX announcement dated 11 February 2015 for further details). As such, on the date Atlantic Ltd lost control of its subsidiaries it also lost control of \$25.262 million cash held by these subsidiaries. This has been included in section 1.12 above.
