

**ISSUE OF ANGLO AUSTRALIAN RESOURCES NL SHARES – SECONDARY TRADING NOTICE - NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")**

On 22 June 2015, Anglo Australian Resources NL ("**Company**") issued 25,500,000 fully paid ordinary shares at an issue price of \$0.01 each ("**Securities**").

**Secondary Trading Exemption**
