Lodgement of Appendix 4C: Consolidated Statement of Cash Flows for the June 2015 Quarter

Commentary

Australian Renewable Fuels Limited (ARfuels) presents its Appendix 4C: Consolidated Statement of Cash Flows for the June 2015 quarter. Key highlights for the quarter include:

- Net operating cash inflows of \$0.263m for the quarter and year to date of \$1.818m.
- Planned investment in property, plant and equipment of \$0.457m for the quarter resulted in a net cash outflow of \$0.194m, however year to date net cash inflows are \$0.781m.

ARfuels reports a cash at bank position of \$1.737m as at 30 June 2015 and an undrawn debt facility of \$5.5m.

The full year net operating cash inflows of \$1.818m, the favourable resolution of the biodiesel excise position, together with the execution of new sales contracts for supply from the Barnawartha plant, provides a sustainable and positive platform for the business going forward.

Our 30 June 2015 financial results will be finalised and released in August 2015.
