

# SHARE PURCHASE PLAN OFFER OVERSUBSCRIBED

**26 August 2015**: Mint Payments Limited (**ASX:MNW**) is pleased to annouce that it has successfully completed its Share Purchase Plan ("SPP").

The Company received strong support from shareholders, with the SPP being oversubscribed. The SPP will be scaled back to the \$1,000,000 cap previously announced.

The SPP, which closed on the 19<sup>th</sup> August 2015, has resulted in a total of 16,393,384 securities being issued at \$0.061 per share as per the attached Appendix 3B. Refunds for oversubscriptions and holding statements will be despatched from the 26<sup>th</sup> August 2015.

Together with the recent \$4M placement to global fintech investor Vix Investments Limited, the SPP now completes the A\$5M raising announced to the market on 21<sup>st</sup> July 2015.

CEO/ Managing Director Alex Teoh, said, "We have been very encouraged by our shareholders response to the SPP and would like to thank them for their ongoing support".
