Vocus delivers another record performance

Vocus Communications Limited (ASX: VOC) is pleased to announce another record result for the financial year ended 30 June 2015.

Financial Highlights

- Revenue up 62% to \$149.8m
- Underlying EBITDA up 56% to \$51.6m
- Underlying NPAT up 34% to \$18.1m
- Operating cash flow up 39% to \$42.6m
- FY15 total dividend up 78% to 3.2 cents per share, fully franked¹

Commentary

Highlights for the year included strategic acquisitions of FX Networks in New Zealand and Bentley and EDC data centres in Australia. Vocus was also admitted to the ASX200.

The results were achieved through a combination of organic growth (approximately 40% of the total) and the inclusion of acquired businesses for parts of the year. Amcom Telecommunications was acquired after the year-end, so is not included in these results.

All divisions have shown significant revenue growth. The fastest growing segments were Fibre/Ethernet, up 129% to \$64.5m, Voice, with 67% growth to \$12.3m, Data Centres, up 43% to \$26.6m and Internet up 17% to \$43.9m.

The Fibre network now reaches over 3,315 buildings (including Amcom) (up 216%) with a fibre network extending 1,606km in Australia (up 175%) and 4,369km in New Zealand (up 5%).

Given the strong results, a final dividend of 2.0 cents per share, fully franked, will be paid. Including the interim dividend of 1.2 cents per share, total dividends for FY15 amount to 3.2 cents per share, up 78% on 2014. In addition, a special dividend of 5.1 cents per share was paid prior to the Amcom acquisition completion.
