BUY-BACK AND CANCELLATION OF AVEO GROUP STAPLED SECURITIES

Aveo Group today issues a final share buy-back notice (Appendix 3F) with respect to the on-market buy-back that was announced on 20 August 2014 which operated from 4 September 2014 to 3 September 2015.

In accordance with ASX Listing Rule 3.8A, attached is a copy of Form 484 lodged with the Australian Securities and Investments Commission in relation to the cancellation of 200,000 Aveo Group stapled securities, which completes the cancellation of Aveo Group Securities with respect to the buy-back that operated from 4 September 2014 to 3 September 2015.

The total number of Aveo Group stapled securities that have been brought back and cancelled since the commencement of the buy-back activity on 23 September 2014 is 827,146. There are 515,230,885 stapled securities on issue following this cancellation.

Aveo Group announced a further on-market buy-back on 19 August 2015, which will operate from 4 September 2015 to 3 September 2016.
