AFFINITY SHAREHOLDERS VOTE IN FAVOUR OF SCHEME OF ARRANGEMENT

At the Scheme Meeting of Affinity Education Group Limited (**Affinity**) (ASX:AFJ) held in Melbourne today, Affinity shareholders voted overwhelmingly in favour of the scheme of arrangement under which Anchorage Childcare Pty Limited (**Anchorage Childcare**) proposes to acquire all of the shares in Affinity (**Scheme**).

Voting results

Affinity advises that the resolution to approve the Scheme, as set out in the Notice of Scheme Meeting in Annexure D of the Scheme Booklet, was passed by the requisite majorities of Affinity shareholders. The poll report submitted by the returning officer appointed by Affinity is attached.

Next steps

Affinity has applied to the Federal Court of Australia (**Court**) for approval of the Scheme at a hearing scheduled for Monday, 30 November 2015. If the Court approves the Scheme, Affinity shareholders (**Scheme Shareholders**) who hold shares (**Scheme Shares**) on the Scheme Record Date (which is currently expected to be 7:00 pm (Melbourne time) on Tuesday, 8 December 2015) will be entitled to receive the Scheme Consideration of \$0.92 cash for each Scheme Share. The Scheme Consideration will be sent to Scheme Shareholders on the Implementation Date (which is currently expected to be Tuesday, 15 December 2015). The key dates for implementation of the Scheme are set out below:
