Iluka Resources Limited (Iluka) announces the following changes to its Board of Directors.

Retirement of Mr Wayne Osborn

Mr Wayne Osborn has today announced his intention to retire as a director of the Company effective from the close of the 2016 Annual General Meeting scheduled for May 2016. Mr Osborn currently serves as an independent non-executive director and Chairman of the People and Performance Committee.

Mr Greg Martin, Iluka's Chairman, stated: "We thank Wayne for his service and contribution as a director. Iluka has been fortunate to be the beneficiary of Wayne's professionalism and dedication over the six years he will have served on the Board by the time of his retirement.
