## CLARIFICATION OF EXTENDED CLOSING DATE FOR RIGHTS ISSUE

On the 4<sup>th</sup> January 2016 A-Cap Resources Limited ("A-Cap" or "Company") announced that the Closing Date for the non-renounceable rights issue had been extended to the 8<sup>th</sup> February 2016 in order to allow eligible shareholders additional time to consider participation in the offer.

The offer relates to a prospectus dated 3<sup>rd</sup> December 2015 to raise \$5 million by way of a non-renounceable entitlement offer to shareholders of approximately 250,000,000 new ordinary shares on the basis of 1 new ordinary share in the Company for every 1.9 ordinary shares held, at an issue price of 2 cents per share which will be fully underwritten (**Rights Issue**).
