S&P CREDIT RATING DOWNGRADE

Standard & Poor's Ratings Services lowered its credit rating for Emeco from 'B-' to 'CCC+' on 15 January 2016. This brings Standard & Poor's rating in line with Moody's rating downgrade in July 2015.
