## **Results for announcement to the market (continued)**

### ***Significant features of operating performance***

The Company is currently invested in Australian fixed and floating securities, with a total face value of \$46.6 million, of which \$9.5 million is due to mature within the next 12 months of the balance date.

The profit of the Company for the half-year after providing for income tax amounted to \$871,177 (2014: \$2,322,943). The net asset value per share at 31 December 2015 was \$55.92 (30 June 2015: \$61.52). The decline in the Company's profit was primarily driven by the reduction of the income producing assets of the Company as financial investments matured during the period with the proceeds being paid out as capital returns to investors.

The weighted average number of shares for the half-year was 904,456. The basic and diluted earnings per share after tax was \$0.96 (2014: \$2.57).

### ***Events subsequent to reporting date***

On 28 January 2016, the Company announced a fully franked dividend payment of \$0.32 per share and a capital return of \$3.31 per share which represents the Fourth Return of Capital approved by shareholders on 25 November 2015 at the Annual General Meeting. The dividend and capital return were paid to shareholders on 15 February 2016.

There has not been any other event of a material and unusual nature likely to significantly affect the operations of the Company, the results of those operations, or the state of affairs of the Company, in future financial years.

## DIRECTORS' REPORT

FOR THE HALF-YEAR ENDED 31 DECEMBER 2015

The directors present their report together with the condensed financial report of Australian Masters Yield Fund No 1 Limited ("the Company") for the half-year ended 31 December 2015.

### Principal Activities

The principal activity of the Company during the half-year was investing in Australian fixed and floating income securities.

### Results and Review of Operations

The profit of the Company for the half-year after providing for income tax amounted to \$871,177 (2014: \$2,322,943). The net asset value of the Company at 31 December 2015 was \$50,573,050 (30 June 2015: \$55,644,149). The net asset value per share at 31 December 2015 was \$55.92 (30 June 2015: \$61.52). The decline in the Company's profit was primarily driven by the reduction of the income producing assets of the Company as financial investments matured during the period with the proceeds being paid out as capital returns to investors.

The weighted average number of shares for the half-year was 904,456. The basic and diluted earnings per share after tax was \$0.96 (2014: \$2.57).

As approved by shareholders at the General Meeting held on 13 November 2014, the Company made its Second Capital Return of \$5.64 per share on 4 December 2015.

### Dividends Paid or Recommended

During the half-year, the Company paid fully franked dividends of \$0.29 per share paid on 18 August 2015 and \$0.64 per share on 4 December 2015. The total amount of the dividends paid was \$262,292 and \$578,852 respectively.

**1. Statement of Significant Accounting Policies**

**a. Basis of Preparation**

These general purpose condensed financial statements for the interim half-year reporting period ended 31 December 2015 have been prepared in accordance with the requirements of the *Corporations Act 2001* and Australian Accounting Standards including AASB 134: Interim Financial Reporting. Compliance with AASB 134: Interim Financial Reporting ensures that the financial statements and notes also comply with IAS 34: Interim Financial Reporting.

This interim financial report is intended to provide users with an update on the latest annual financial statements of Australian Masters Yield Fund No 1 Limited ("the Company"). It is therefore recommended that this interim financial report be read in conjunction with the annual financial statements of the Company for the year ended 30 June 2015.

Other than as noted below, the same accounting policies and methods of computation have been followed in this interim financial report as were applied in the most recent annual financial statements.

The condensed financial statements have been prepared on an accruals basis and are based on historical costs, modified where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. All amounts are presented in Australian dollars, unless otherwise noted.

The interim financial report was authorised for issue on 23 February 2016 by the board of directors.

**New or revised Standards and Interpretations that are first effective in the current reporting period**

The Company has adopted all of the new and revised Standards and Interpretations issued by the Australian Accounting Standards Board (the AASB) that are relevant to their operations and effective for the current half-year.

No new or revised Standards and Interpretations effective for the period under review are considered to have any impact on the disclosures or the amounts recognised in the financial statements.

Mr Alexander MacLachlan is a director of the Company and director of the Manager, Walsh & Company Asset Management Pty Limited (“the Manager”).

The Manager is entitled to receive a management fee of 0.59% (excluding GST) per annum of the Value of the Portfolio. During the half-year ended 31 December 2015, Walsh & Company Asset Management Pty Limited was paid in advance an annual management fee of \$362,457 (2014: \$593,229), inclusive of GST. Of the total management fee, \$168,872 is included in prepayments at 31 December 2015 (2014: \$276,391).

Australian Fund Accounting Services Pty Limited

Australian Fund Accounting Services Pty Limited, a wholly-owned subsidiary of Dixon Advisory Group Limited, the parent of the Manager, provides fund administration services under an agreement with the Manager. These services include net asset valuation, management accounting, statutory reporting, capital management and taxation.

Total fund administration fees paid or payable for the half-year ended 31 December 2015 were \$45,000 (2014: \$55,207), exclusive of GST.

## **Independent Auditor's Review Report to the members of Australian Masters Yield Fund No 1 Limited**

We have reviewed the accompanying half-year financial report of Australian Masters Yield Fund No 1 Limited, which comprises the condensed statement of financial position as at 31 December 2015, and the condensed statement of profit or loss and other comprehensive income, the condensed statement of cash flows and the condensed statement of changes in equity for the half-year ended on that date, notes comprising a summary of significant accounting policies and other explanatory information, and the directors' declaration as set out on pages 4 to 12.

### *Directors' Responsibility for the Half-Year Financial Report*

We confirm that the independence declaration required by the *Corporations Act 2001*, which has been given to the directors of Australian Masters Yield Fund No 1 Limited, would be in the same terms if given to the directors as at the time of this auditor's review report.

## *Conclusion*

Based on our review, which is not an audit, we have not become aware of any matter that makes us believe that the half-year financial report of Australian Masters Yield Fund No 1 Limited is not in accordance with the *Corporations Act 2001*, including:

- (a) giving a true and fair view of the company's financial position as at 31 December 2015 and of its performance for the half-year ended on that date; and
- (b) complying with Accounting Standard AASB 134 *Interim Financial Reporting* and the *Corporations Regulations 2001*.
