

# APPOINTMENT OF GENERAL MANAGER AT ANTAS COPPER MINE

### General Manager - Otavio Monteiro

Mr Monteiro is a chemical engineer and veteran of approximately 25 years' in the metallurgical and chemical industries. He was a General Manager with Vale's aluminium companies Alunonorte and Albras, responsible for the aluminium refinery and smelting plants respectively. Mr Monteiro holds an MBA and is a native of northern Brazil.

## Plant Manager - Jair Hipólito

Mr Jair Hipólito is a mineral processing engineer with 24 years in the extractive industry. Mr Hipólito has worked with a number of majors including Anglo America, Rio Tinto, Votorantim, Yamana and Vale. He began his career as a technician working his way up to supervisor, later graduating as a metallurgical engineer. Formerly a manager of Vale's giant Salobo copper flotation concentrator, Mr Hipólito was responsible for all production activities associated with the production of ~300,000tpa of copper in concentrate.
