

Western Areas Limited - Share Purchase Plan

Introduction

On behalf of the directors of Western Areas Limited (**Western Areas**), I am pleased to offer eligible shareholders (as defined in the **enclosed** Terms and Conditions) (**Eligible Shareholders**) the opportunity to participate in the Western Areas Share Purchase Plan (**SPP**).

Pursuant to the SPP Eligible Shareholders are invited to apply for up to A\$15,000 worth of new fully paid ordinary shares in Western Areas (**New Shares**) (subject to discretionary scale back) without paying any brokerage or other transaction costs. The SPP proceeds will be capped at A\$10 million and Western Areas reserves the right to scale back applications.

The offer under the SPP is only open to Eligible Shareholders who were registered as holders of fully paid ordinary shares in Western Areas as at 7.00 pm (Sydney time) on Wednesday, 30 March 2016 and whose registered address is in Australia or New Zealand. Participation in the SPP is optional, but the right of Eligible Shareholders to participate in the SPP is not transferable.

Purposes of the SPP and use of funds

On 31 March 2016, Western Areas announced an underwritten placement to institutional, professional and sophisticated investors to raise approximately A\$60 million (**Placement**) and the SPP. The SPP will not be underwritten. Assuming the full amount of A\$10 million is raised from the SPP, approximately A\$70 million will be raised in total. The funds from the Placement and SPP will be used for the following purposes:

- To replenish working capital for the total purchase price and transaction costs for Cosmos of approximately A\$26 million.
- For repayment of amounts drawn under the ANZ corporate facility of A\$25 million.
- To continue to invest in project growth such as exploration at Cosmos and Western Gawler, and the advancement of study work to pre-feasibility status ("PFS") at Odysseus later in the year. Post the PFS, the initial estimate for the investment required to move to a Bankable Feasibility Study at Odysseus is approximately A\$5 million.
- To provide greater financial and operational flexibility to enable the previously announced deferred discretionary capital projects (such as vertical development at Spotted Quoll and the Mill Recovery Enhancement Project) and exploration programs to be promptly and efficiently recommenced as and when justified by the nickel market environment.
- For general working capital purposes including the payment of the costs of the equity raising.

For further details as to the proposed use of funds, refer to investor presentation released by Western Areas in connection with the Placement on 31 March 2016.

Summary of key details

Eligible Shareholders may subscribe for New Shares at an issue price of A\$2.00 per share which is the same price at which institutional investors took up new shares under the Placement and represents a discount of approximately 7.4% to the closing price of A\$2.16 per Western Areas share on 30 March 2016 (being the last trading day prior to announcement of the Placement and SPP).

If you are an Eligible Shareholder, you may apply to purchase a parcel of New Shares in A\$2,500 increments from a minimum of A\$2,500 up to a maximum of A\$15,000 without incurring brokerage.

As noted above, you may only apply for a maximum amount of A\$15,000 worth of New Shares. If you have two or more registered holdings, the total of all the applications must not exceed A\$15,000. Western Areas reserves the right to decline applications from multiple registered holdings if the total exceeds A\$15,000, including where those registered holdings are in similar but not identical names, are directly or indirectly or are held alone or with others.

Western Areas intends to raise up to a maximum of A\$10 million under the SPP. Western Areas intends to scale back applications should total demand exceed A\$10 million in its absolute and sole discretion. Western Areas may take into account, among other factors, the size of an applicant's shareholding in determining the amount (if any) by which to scale back that applicant's application. Should this occur, you may be allocated New Shares to a value which is less than the parcel for which you applied and the difference will be refunded to you without interest. Full details of the SPP are set out in the **enclosed** Terms and Conditions and Application Form.

The SPP opens on Wednesday, 6 April 2016. To apply for New Shares under the SPP, Eligible Shareholders may either:

- complete and return their enclosed Application Form in accordance with the details on the form, together with a cheque, bank draft or money order drawn on an Australian bank in Australian dollars; or
- pay directly via BPAY¹ on the internet or by telephone (for shareholders with an eligible Australian bank account only).

Application Forms must be received by Western Areas' share registry, or a BPAY payment must be received, by no later than 5.00pm (Sydney time) on Wednesday, 27 April 2016.

You should be aware that the market price of Western Areas shares on ASX may rise and fall between the date of the SPP offer and the date that the New Shares are issued under the SPP. As a result, the number of New Shares that you receive may be more or less than the number that you might calculate using the market price of Western Areas shares on the date the New Shares are issued.

The SPP does not take into account your individual investment objectives, financial situation, tax position or particular needs. You should consider seeking independent financial and taxation advice before making a decision as to whether or not to accept the offer.

SHARE PURCHASE PLAN TERMS AND CONDITIONS

Eligible Shareholders have the opportunity to participate in the Western Areas Share Purchase Plan offer (**SPP**) by subscribing for up to A\$15,000 of new fully paid ordinary shares in Western Areas (**New Shares**) without incurring brokerage or transaction costs. The terms and conditions of this offer, including how to participate are set out below.

No cooling off rights apply to applications submitted under the SPP. The commencement of quotation of the New Shares issued under the SPP is subject to confirmation from ASX.

2. ARE YOU AN ELIGIBLE SHAREHOLDER?

- (a) If you:
- (i) were registered as a holder of Western Areas ordinary shares as at the Record Date (being 7.00 pm (Sydney time) on Wednesday, 30 March 2016) and your registered address is in Australia or New Zealand; and
 - (ii) do not hold shares on behalf of persons who reside outside Australia or New Zealand, are not located in the United States and are not acting for the account or benefit of a person located in the United States,
- you will be eligible to participate in the SPP and an **Eligible Shareholder**.
- (b) The Directors who are Eligible Shareholders may participate in the SPP.
- (c) Western Areas has determined that it is not reasonably practical for holders of Western Areas shares with registered addresses in jurisdictions outside Australia or New Zealand to participate in the SPP having regard to the number of such holders and the costs of complying with regulatory requirements in other countries. Joint Holders	If you are recorded with one or more other persons as the joint holder of a holding of Western Areas shares, that joint holding is considered to be a single registered holding for the purpose of the SPP, and the joint holders are entitled to participate in the SPP in respect of that single holding only. If the same joint holders receive more than one offer under the SPP due to multiple registered holdings, the joint holders may only apply for one maximum parcel of New Shares with an aggregate value of no more than A\$15,000.

4. PARTICIPATION IS OPTIONAL

Participation in the SPP is entirely optional (subject to the eligibility criteria set out in section 2 above). The offer to acquire New Shares is not a recommendation. If you are in any doubt about the SPP, or as to whether you should participate in the SPP or how participation will affect you, Western Areas encourages you to seek independent financial and taxation advice before making a decision as to whether or not to accept this offer and, if so, how much to invest.

5. RISKS ASSOCIATED WITH PARTICIPATING IN THE SPP

- (a) You should note that Western Areas' share price may rise or fall between the Record Date, the date of this offer, the date on which you make a BPAY payment or send in an Application Form and the date when New Shares are allotted and issued to you under the SPP. This means that the issue price of A\$2.00 per New Share pursuant to this offer may be either higher or lower than the Western Areas share price, up to or after the date the New Shares are issued and allotted to you under the SPP and you therefore may be able to buy shares at a lower price on market than the issue price.
- (b) Western Areas recommends that you monitor the Western Areas share price and any Western Areas announcements, which can be found on Western Areas website at www.westernareas.com.au or on the ASX website at www.asx.com.au (ASX code: WSA). Western Areas' share price can also be found in the financial pages of major Australian metropolitan newspapers.
- (c) Western Areas encourages you to contact your professional adviser regarding whether or not to participate in the SPP and, if so, how much to invest.

6. OFFER PRICE

Under the SPP, Eligible Shareholders have an opportunity to subscribe for up to A\$15,000 for Western Areas shares at an offer price of A\$2.00 per New Share which is the same price at which institutional investors took up new shares under the Placement and represents a discount of:

- (a) approximately 7.4% to the closing price of A\$2.16 per Western Areas share on 30 March 2016 (being the last trading prior to announcement of the Placement and SPP).

You agree to pay the issue price per New Share for the number of New Shares calculated under section 9 or, if there is a scale-back, the number of New Shares calculated under section 8 of these Terms and Conditions.

7. HOW MUCH CAN YOU INVEST?

- (a) Under the SPP, you may apply for a parcel of New Shares in A\$2,500 increments from a minimum of A\$2,500 up to a maximum of A\$15,000. The A\$15,000 limit applies irrespective of the number of Western Areas shares you hold on the Record Date.
- (b) The offer under the SPP needs to comply with the conditions of ASIC Class Order [CO 09/425]. Under that class order, eligible shareholders may only acquire up to a maximum of A\$15,000 worth of Western Areas shares under a share purchase plan or similar plan in any 12 month period (except in certain circumstances described in "Participation by Eligible Shareholders" in section 3 above).
- (c) This limitation applies, for example, even if you receive more than one Application Form or if you hold Western Areas shares in more than one capacity, for example, if you are both a sole and joint holder of Western Areas shares. Please refer to the information under "Participation by Eligible Shareholders" in section 3 above.
- (d) Western Areas reserves the right, and in certain circumstances may be required by ASIC Class Order [CO 09/425] or other conditions, to reject any application for New Shares under the SPP to the extent it considers, or is reasonably satisfied, that the application (whether alone or in conjunction with other applications) does not comply with these requirements.

8. APPLICATIONS MAY BE SCALED BACK

- (a) Western Areas intends to raise up to A\$10 million under the SPP. Western Areas reserves the right to scale back applications should total demand exceed A\$10 million in its absolute and sole discretion. In determining the amount (if any) by which to scale back an applicant's application, Western Areas may take into account, among other factors, the size of an applicant's shareholding in determining the amount (if any) by which to scale back that applicant's application. Should this occur, you may be allocated New Shares to a value which is less than the parcel for which you applied for.
- (b) If a scale back produces a fractional number when applied to the parcel of New Shares you applied for, the number of New Shares you will be allotted will be rounded up to the nearest whole number and any difference will be refunded to you without interest.
- (c) Any application monies refunded by Western Areas under a scale back will be paid by cheque or direct credit (the payment method will be determined by Western Areas in its absolute discretion) in Australian currency, on or around Monday, 16 May 2016. By applying for New Shares, each shareholder authorises Western Areas to pay any monies to be refunded by using the payment instructions of the shareholder recorded in Western Areas share registry's records, if Western Areas should elect to pay in this manner.

9. CALCULATION OF THE NUMBER OF NEW SHARES TO BE ISSUED TO YOU

In the absence of a scale back, and subject to the treatment of non-compliant applications described under "General Application Terms" in section 19 below, the number of New Shares to be issued to you will be calculated by dividing the aggregate application money that you pay in applying for New Shares by the issue price, then rounding up to the nearest whole number. For example, in the absence of a scale back, if you subscribe for A\$15,000 for New Shares at the issue price of A\$2.00 per New Share, you will be allotted 7,500 New Shares.

10. NON-RENOUNCEABLE OFFER

The offer to subscribe for New Shares under the SPP is non-renounceable. This means that you cannot transfer your right to subscribe for New Shares under the offer to anyone else.

11. NO BROKERAGE

No brokerage is payable by you to Western Areas in respect of the acquisition of New Shares under the SPP.

12. RANKING OF NEW SHARES

- (a) All New Shares issued under the SPP will rank equally with existing Western Areas ordinary shares from the date of issue, and therefore will carry the same voting rights, dividend rights and other entitlements as existing Western Areas ordinary shares.
- (b) Western Areas will apply for New Shares issued under the SPP to be quoted on the ASX.

13. COMPLIANCE

- (a) The offer of New Shares under the SPP is made to existing Western Areas shareholders in accordance with the requirements of ASIC Class Order [CO 09/425]. This instrument grants relief from the requirement to prepare a prospectus for the offer of New Shares under the SPP.

This document is not a prospectus and has not been registered with the Australian Securities & Investments Commission and does not, and is not requested to, contain all the information that a prospectus under Australian law is required to contain.

- (b) The New Shares are not being offered or sold to the public within New Zealand other than to existing shareholders of Western Areas with registered addresses in New Zealand to whom the offer of New Shares is being made in reliance on the Securities Act (Overseas Companies) Exemption Notice 2013 (New Zealand).

14. BINDING TERMS

By accepting the offer to purchase New Shares under the SPP, you agree to be bound by these Terms and Conditions and the Western Areas constitution.

15. HOW TO APPLY

If you are an Eligible Shareholder and would like to apply for New Shares under the SPP, you can either:

- (a) complete the Application Form and, together with a cheque, bank draft or money order for the relevant amount, forward it to Western Areas' share registry; or
- (b) make a BPAY payment.

17. APPLYING BY BPAY PAYMENT

Eligible Shareholders who wish to pay by BPAY, must follow the instructions on the Application Form. Payment must be received by Western Areas' share registry by **no later than 5.00 pm (Sydney time) on Wednesday, 27 April 2016**. Your personalised Application Form sets out the Biller Code and your unique customer reference number, which you must use to take up the offer.

You can obtain a copy of your personalized Application Form online at www.investorcentre.com. If you have not logged into the Computershare Investor Centre previously, select the 'Access a Single Holding' button, enter your SRN/HIN postcode and follow the prompts. Your personalised Application Form contains your personalised BPAY customer reference number.

Applicants using BPAY should be aware that their own financial institution may implement earlier cut off times with regards to electronic payment, and should therefore take this into consideration when making payment. It is the responsibility of the applicant to ensure that funds submitted through BPAY are received by this time.

If you make your payment using BPAY, you do not need to return your Application Form.

18. YOUR REPRESENTATIONS

By completing and submitting the Application Form (together with a cheque, bank draft or money order) **or making a BPAY payment, you represent and certify** on your own behalf and on behalf of each person on whose account you are acting that:

- (a) you are an Eligible Shareholder and eligible to participate in the SPP for the number of New Shares applied for;

- (b) you acknowledge that the New Shares have not, and will not be, registered under the US Securities Act or the securities laws of any state or other jurisdictions in the United States, or in any other jurisdiction outside Australia or New Zealand and accordingly, New Shares may not be offered, sold or otherwise transferred except in accordance with an available exemption from, or a transaction not subject to, the registration requirements of the US Securities Act and any other applicable securities laws;
- (c) you have not, and will not, send any materials relating to the SPP to any person in the United States, or that is acting for the account or benefit of any person in the United States, or to any person in any country outside Australia and New Zealand, and agree to provide (and direct your nominee or custodian to provide) any requested substantiation of your eligibility to participate in the SPP and of your holding of Western Areas Shares at the Record Date;
- (d) you acknowledge that you have not been provided with investment advice or financial product advice by Western Areas or Computershare Investor Services Pty Limited and that neither of them has any obligation to provide this advice in relation to your consideration as to whether or not to purchase Western Areas shares;
- (e) you acknowledge that the market price of Western Areas shares may rise or fall between the date of this offer and the Issue Date and that the issue price you pay for the New Shares may exceed the market price of the Western Areas shares on the Issue Date;
- (f) you authorise Western Areas (and its officers or agents) to correct any minor error or omission in your Application Form and to complete the Application Form by the insertion of any missing details;
- (g) you acknowledge that Western Areas may at any time determine that your Application Form is valid, in accordance with the Terms and Conditions, even if the Application Form is incomplete, contains errors or is otherwise defective;
- (h) you accept the risk associated with any refund that may be sent to you by direct credit to your nominated account of cheque to your address shown on Western Areas' register;
- (i) you are responsible for any dishonour fees or other costs Western Areas may incur in presenting a cheque for payment which is dishonoured;
- (j) you acknowledge that Western Areas is not liable for any exercise of its discretions referred to in these Terms and Conditions;
- (k) you declare that you are at least 18 years of age and have full legal capacity and power to perform all your rights and obligations under the Application Form;
- (l) you authorise Western Areas to register you as the holder(s) of shares issued to you;
- (m) you irrevocably and unconditionally agree to these Terms and Conditions and the terms of the Application Form and agree not to do any act or thing which would be contrary to the spirit, intention or purpose of the SPP;
- (n) you acknowledge your application is irrevocable and unconditional;
- (o) the aggregate of the application price paid by you for:
 - (i) the New Shares the subject of your Application Form or BPAY payment; and
 - (ii) any other New Shares applied for by you under the SPP or any similar share purchase plan arrangement operated by Western Areas in the 12 months prior to the date of submission of the Application Form or BPAY payment; and
 - (iii) any other New Shares which you have instructed a Custodian to acquire on your behalf under the SPP; and

- (iv) any other Western Areas shares issued to a Custodian in the 12 months before the application as a result of an instruction given by you to the Custodian or another custodian to apply for shares on your behalf under an arrangement similar to the SPP, and which resulted in you holding the beneficial interest in those shares,

does not exceed A\$15,000, unless you are applying as a Custodian for one or more Participating Beneficiaries and have provided Western Areas with the Custodian Certificate referred to under "Participation by Eligible Shareholders" in section 3 above.

19. GENERAL APPLICATION TERMS

- (a) Do not forward cash. Receipts for payment will not be issued. Western Areas reserves the right not to accept Application Forms or BPAY payments received after 5.00pm (Sydney time) on Wednesday, 27 April 2016.
- (b) Applications may only be made for parcels of New Shares in the amounts of a minimum of A\$2,500, and after that, in multiples of A\$2,500, up to a maximum of A\$15,000. If the amount of the payment tendered with your Application Form or your BPAY payment is:
 - (i) less than A\$2,500 - Western Areas will not allot any New Shares to you and will refund your application money to you, without interest payable to you;
 - (ii) greater than A\$15,000 - subject to scale back, Western Areas will allot the maximum number of New Shares to you and will refund the excess application money to you, without interest payable to you; or
 - (iii) not a multiple of A\$2,500 that is more than A\$2,500 and less than A\$15,000 - subject to scale back, Western Areas will allot to you the number of New Shares that would have been allotted had you applied for the highest amount you were permitted to apply for that is less than the amount of your cheque or BPAY payment, and will refund the excess application money to you, without interest payable to you.
- (c) Application Forms must be received by Western Areas share registry and BPAY payments must be received by **no later than 5.00pm (Sydney time) on Wednesday, 27 April 2016**. Application Forms and BPAY payments received after that time will not be accepted.

20. ISSUE AND QUOTATION DATES

- (a) New Shares are expected to be issued under the SPP on Thursday, 5 May 2016 and Western Areas will apply for those New Shares to be listed for quotation on ASX on or before Friday, 6 May 2016.
- (b) Western Areas expects to dispatch a holding statement or confirmation advice in respect of the New Shares allotted to you under the SPP on Monday, 9 May 2016. You should confirm your holding before trading in any New Shares you believe have been allotted to you under the SPP.

21. UNDERWRITING

The SPP will not be underwritten.

22. WITHDRAWAL, SUSPENSION, TERMINATION, ANOMALIES AND DISPUTES

- (a) Western Areas reserves the right to waive strict compliance with any provision of these Terms and Conditions, to amend or vary these Terms and Conditions and to suspend or terminate the SPP at any time. Any such amendment, variation, suspension or termination will be binding on all Eligible Shareholders even where Western Areas does not notify you of that event.
- (b) Western Areas may make determinations in any manner it thinks fit, including in relation to any difficulties, anomalies or disputes which may arise in connection with or by reason of the operation of the SPP, whether generally or in relation to any participant or application. Any determination by Western Areas will be conclusive and binding on all Eligible Shareholders and other persons to whom the determination relates.
- (c) Western Areas rights may be exercised by the Board or any delegate of the Board.
