Further to the ASX Announcements dated 18 May 2016 and 1 February 2016 the Companies provide the following update.

# Reliance on Australian Securities Investment Commission (ASIC) Extension of Temporary Financial Reporting Relief further extension.

The Companies of COK were relying on ASIC Corporations Instruments for temporary reporting relief; 16-0410 relating to COK, 16-0412 Baralaba Coal Pty Limited and 16-0413 relating to Wonbindi Coal Pty Limited (each an **ASIC Instrument** and together, the **ASIC Instruments**).

The ASIC Instruments were provided to temporarily relieve the Companies from the obligation to provide financial statements for the period ending December 31 2016 until the earlier of; the day that is 24 months after the date of the ASIC Instrument and the date that the entity ceases to be under a Deed of Company Arrangement.

As the Deed of Company Arrangement (DOCA) effectuated and the deed administration terminated on 31 May 2016, the temporary relief was due to expire.

We now advise that the Company will rely on the attached ASIC Instruments which vary the expiry date of the previous instruments until 17 June 2016.
