RE: ALLOTMENT OF SHARES – SHARE PURCHASE PLAN

BPH Energy Ltd is pleased to confirm that the issue of shares under its Share Purchase Plan (“SPP”) is now complete. The plan was significantly oversubscribed with applications in excess of \$800,000 being received. As the Company can only issue a maximum of 30% of its share capital pursuant to the SPP an amount of approximately \$425,000 has been refunded.

The final issue price under the SPP was \$0.00533 per share and total of 70,730,318 shares were issued.

The directors of BPH Energy would like to thank shareholders for their continued support.

Application for listing of the shares on the Australian Securities Exchange will be made and notifications to shareholders will be sent today.
