Molopo Energy Limited ("Molopo" or the "Company") presents its quarterly report for the three months ended 30 June 2016

Capital and Operations:

At the end of the quarter, Molopo holds cash reserves of AU\$67.7 million, an increase of \$318k from the end of the previous quarter due to foreign exchange gain of \$467k and interest on Term Deposits of \$448k exceeding administration and legal expenses of \$597k for the quarter. The Company holds 87% of its cash in Australian dollars, 1% in US Dollars and 12% in Canadian dollars. The Canadian dollars have been retained as a provision for the litigation which sits in the Company's Canadian subsidiary. The Company currently holds AU\$56.6 million on term deposit.

Legal:

The Board continues its efforts to have the litigation dealt with as expeditiously as possible and ensure it is progressed in a cost effective manner. Efforts to resolve the matter with the Plaintiff have not been successful. The Board have received notification from its lawyers that the earliest time to request a trial is July 2018.

Company Strategy:

Given that a trial date could not be requested before July 2018, Molopo continues to assess opportunities in the oil & gas sector. During the quarter, Molopo's Independent Adviser reviewed a number of oil and gas opportunities in stable geographies in either the development or production phase resulting in the Company entering into confidential discussions with a selected investment candidate. Whilst those discussions are ongoing, the Directors are mindful that any material investment in the oil and gas sector or any other sector will require careful consideration of the Board prior to seeking shareholder approval.
