
Mr Woo Chiu Man, Cliff has been appointed as Director of the Company with effect from 1 August 2016.

He was in various senior technology management positions in the telecommunications industry before joining in 1998 the Hutchison Whampoa Limited group, a wholly owned subsidiary of CK Hutchison Holdings Limited. He was deputy managing director of Hutchison Telecommunications (Hong Kong) Limited from 2000 to 2004, and executive director from March 2005 to December 2005 and alternate director from December 2005 to May 2010 of Hutchison Telecommunications International Limited. He was seconded to Vodafone Hutchison Australia Pty Limited ("VHA") as chief technology officer from 2012 to 2013 and was part of the core management team. Mr Woo has been alternate director to Mrs Susan Chow of VHA since July 2013. He is now chief technology officer at Hutchison Asia Telecommunications Limited overseeing all technology aspects, technology management, investment planning and cost optimization of the group. Mr Woo holds a Bachelor's degree in Electronics and a Diploma in Management for Executive Development. He is a Chartered Engineer and also a Member of The Institution of Engineering and Technology (UK) and the Hong Kong Institution of Engineers.
