BUY-BACK AND CANCELLATION OF AVEO GROUP STAPLED SECURITIES

Aveo Group (ASX:AOG) comprising Aveo Group Limited and Aveo Funds Management Limited as Responsible Entity for the Aveo Group Trust today issues a final share buy-back notice (**Appendix 3F**) with respect to the on market buy-back that was announced on 19 August 2015 which operated from 4 September 2015 to 3 September 2016 (**Buy-back period**).
