

## COMMENCEMENT OF DRILLING AND EXTENSION OF RIGHTS ISSUE CLOSING DATE

Blaze International Limited (ASX: **BLZ**) (Company) (Blaze) is pleased to confirm, following its announcement made 17 November 2016, that RC drilling has commenced on EL45/4699 of the Marble Bar Lithium Project.

The initial program consists of eight (8) holes testing Target area 1A and 1B, eight (8) holes testing Target area 2A and two (2) holes testing Target area 3A (see **Figure 1** above for reference). It is envisaged that the proposed program will extend beyond the current planned holes, which currently represent approximately 1,580m of drilling, subject to results of the initial drill holes and the establishment of drill pads in further high priority locations.

## **EXTENSION OF RIGHTS ISSUE CLOSE DATE**

As announced to the market 19 October 2016, the Company has undertaken to conduct a one (1) for three (3) rights issue at \$0.05 per share to raise \$2.1 million (**Rights Issue**). The Company issued the Prospectus to the Rights Issue on 4 November 2016. The Company has decided to extend the closing date of the Rights Issue to Wednesday, 11 January 2017.

This extension will allow shareholders, who were eligible on the record date, to participate in the Rights Issue with the benefit of the results of the aforementioned drilling that has now commenced.
