

#### CHAIRMAN'S ADDRESS ANNUAL GENERAL MEETING 29<sup>th</sup> NOVEMBER 2016

On behalf of the Directors and staff at Rex I am pleased to report on the results for the past Financial Year 2015/16.

Regrettably FY15/16 saw the Rex Group reporting its first statutory loss in more than a decade. Non-cash write-downs due to the loss of a Defence Contract in October 2015 were the main contributing factor. Continued deterioration in the regional economy and the weaker AUD also played a part in the Group's result. However, the Group still managed to maintain profitability in its operations with an underlying profit before tax of \$4.3M.

The year in review saw some positive and exciting new developments. Rex expanded its network by adding 2 new routes in Western Australia on the 28 February 2016, giving us a solid base to build up a strong regional presence in the very vast territory of WA which is ideally suited for regional aviation. The new operations saw the addition of 3 Saab aircraft to the fleet. Rex's commencement of Snowy Mountains (Cooma) services in March 2016 brought the total number of ports served by Rex to 58.

Pel-Air made up some of the ground lost by the end of the Defence contract by redeploying its Westwind jets for trial medivac operations in Singapore which proved successful.

On the pilot front, Rex's pilot attrition remains manageable within the year. Meanwhile, AAPA was awarded Approved Training Organisation status by the Civil Aviation Authority of Vietnam, opening the doors to foreign cadets for the second time with the arrival of the first batch of 8 cadets in the second half of the year.

Rex made progress in its negotiation with one union group which saw the ground staff EBA ratified in the first half of the year.

In the FY, Rex reached agreement with Wagga Wagga City Council to purchase a new aircraft paint hangar with a 25-year ground lease. Completion of the purchase will be done when the facility has been brought to fit-for-purpose condition.

Whilst the Australian Economic growth remains uncertain, we believe that Rex has a strong base to weather any challenges ahead. Rex's WA operation is expected to contribute 9% of annual passenger numbers. Its fuel hedging initiative is expected to deliver an estimated \$6.5M savings to the Group. We expect strong medivac operations out of Singapore due to the number of tasking received to date. Finally, international enrolment at AAPA is expected to be increasing. We are confident that Rex will emerge stronger in this upcoming year.

## **PERFORMANCE**

- → First statutory loss since FY03 of \$10.7M (before tax)
- → \$15M non cash write down of goodwill and assets related to cessation of Defence contract
- → Business prospects continued to decline with 50% decline in operational profits
- → Remained operationally profitable with Operational PBT of \$4.3M









## **PERFORMANCE**

Group Operational Performance negatively impacted by:

- + Cessation of Defence contract
- → Continued deterioration of regional economy - \$1.2M less pax revenue in traditional network
- → Over 10% deterioration of FX rate on about AUD44M of USD denominated expenses
- → Mobilisation costs for new WA operations

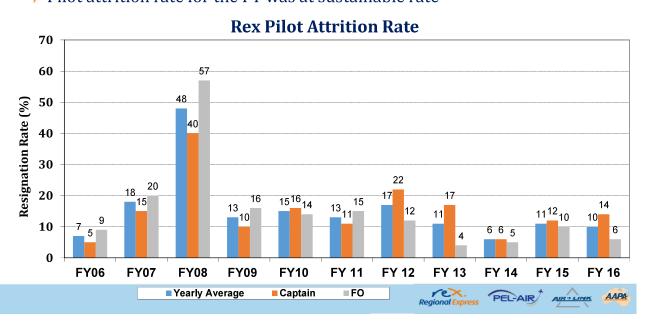






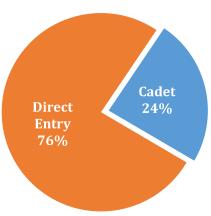
## **PILOT SITUATION**

→ Pilot attrition rate for the FY was at sustainable rate

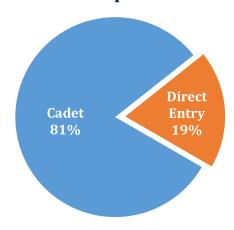


## **REX CADET CPT & FO POPULATION**

- → Improved Cairns Townsville schedule including rationalised capacity from late October 2016
- → Permanent Medivac Operations based out of Singapore









## DIVIDEND

#### In view of the

- sharp decline in operating profits
- + uncertain economic environment ahead

The Board recommends no final dividend. The Board remains committed to an aggressive dividend payout ratio once recovery firmly entrenched.









## **PROFIT FORECAST**

#### **Headwinds:**

- → Economic growth uncertain
- → AUD on declining bias due RBA willingness to further lower rates

#### **Tailwinds:**

- → Full year WA operations contributing annually 9% of passenger numbers
- → Full year fuel reduction estimated to be \$6.5M
- → Strong international enrolment at AAPA
- → Strong medivac performance out of Singapore









## **PROFIT GUIDANCE**

- → Rex Group expected to post stronger performance in FY17 compared to prior period
- → Unable to quantify increased profitability for the full FY guidance to be provided at the half yearly results
