## Resource, Metallurgical and Exploration Drilling Update

#### **Key Points**

- Metallurgical drill hole APDM0004 intersected 60m @ 3.4g/t gold from 112m within the primary zone and 12.8m @ 1.7g/t gold from 87.4m within the transition zone
- Resource infill drill hole APD1329 intersected 53m @ 1.9g/t gold from 70m within the transition zone
- Resource infill drill hole AD1341 intersected 26.3m @ 1.5g/t gold from 63.7m within the transition zone
- Strategic drill hole intersections within the February 2016 Entech optimised open pit outline are generally greater than or in line with the modelled resource grade of 1.6g/t gold.
- Second Exploration hole APRD1327 confirmed the prospectivity of the basal contact of the Black Flag Beds with mineralisation open along strike to the north and at depth
- Three Geotechnical holes have been completed
- Total metres of drilling completed to date 5708.4m
- Prefeasibility study activities for Environmental baseline surveys for Flora & Vegetation, Fauna, Surface Water, Subterranean Fauna, Waste Characterisation and Soil profile determination of the possible open pit outline has been completed.



Aphrodite Gold Limited ("Aphrodite" or "the company") wishes to provide a further update to their Pre-feasibility drill program. The board and management are greatly encouraged by the results to date. The drilling program continues to achieve core recovery > 95% thus providing reliable samples for assay and metallurgical testwork with particular emphasis on the oxide and transition zones of mineralisation. Previous metallurgical testwork indicated that acceptable metallurgical recoveries could be achieved by conventional CIL/CIP processing of the oxide/transition zone mineralisation.

#### **Resource Drilling**


The resource drilling program has been completed with assays for the final 6 holes pending. The focus of the program was on the oxide and transition zones within the modelled resource and February 2016 Entech optimised open pit. Some drill holes were extended into the gold bearing primary sulphide mineralisation to provide confirmation of earlier reverse circulation drilling results and additional drilling density.

Significant transition zone mineralisation was intersected in APD1329 of 53m @ 1.89 g/t gold from 70m including 6.2m @ 5.67 g/t gold from 84.8m (Figure 1). The mineralisation intersected was shallower and extended to a greater depth than had been previously modelled based on Reverse Circulation (RC) drilling.


Significant mineralisation was also intersected within APD1341 (Figure 2) of 12.8m @ 1.68g/t gold from 63.7m. This intersection demonstrated that the mineralisation is continuous between the previously modelled horizontal supergene mineralisation and then near vertical transition and primary mineralisation.

The recent exploration, resource infill and metallurgical drill hole intersections received to date are summarised in Table 1. Previously reported results are in Appendix 2 and include results from APD1326 and APD1328 which intersected transition zone mineralisation of **49.7m @ 2.0g/t gold from 54m** and **25m @ 2.0g/t from 74m** respectively as reported in the Quarterly report dated 28 October 2016.

### **Metallurgical Drilling**




Figure 3- APDM0004 Cross section

Drill hole APDM0004, intersected within the transition zone 12.8m @ 1.68g/t gold from 87.4m and, 60m @ 3.39g/t gold from 112m within the primary sulphide zone (Figure 3). The hole was terminated within the primary mineralisation as the focus of the program was on the transition mineralisation and adequate primary sulphide mineralisation was intersected.

All seven metallurgical drill holes have been completed and intersected the oxide/transition and primary sulphide mineralisation zones as expected. The results for APDM0004 are shown in Table 1. Previously reported results are shown Appendix 2

The metallurgical testwork is in progress with composite intervals from APDM0001- APDM0003 forming 3 metallurgical zones, **transition**, **upper primary and lower primary**. The composite sample head grade of the transition zone of 1.46g/t gold, the upper primary zone of 2.22g/t gold and the lower primary zone of 4.17g/t gold are now subject to metallurgical testing.



### **Exploration Drilling**

The second exploration drill hole, APRD1327, intersected 1.1m @ 1.23g/t gold from 460m at the basal contact between the Black Flag beds and then Western Mafic Unit. This hole was drilled 160m north of APRD1325, which intersected 23m @ 1.3g/t gold at the same contact and confirmed the prospectivity of this contact position which remains open to the north and at depth. Drilling in the future will follow up on these two encouraging exploration drilling results.

#### **Other Pre-feasibility Activities**

All fieldwork relating to the baseline environmental surveys have been completed. This includes Flora & Vegetation, Fauna, Surface Water, Subterranean Fauna, Short-Range Endemic Fauna and Regional Soil surveys.

As part of the Pre-feasibility study Waste Characterisation is required for input into waste dump designs. A suite of 132 samples have been collected from the pulp library onsite and these have been submitted to our Waste Characterisation consultants for testing.

Results and reports from the above mentioned surveys are pending and will be reported once Aphrodite has reviewed the results and recommendations




Figure 4- PFS Drill Program Collar Plan




Figure 1- Aphrodite Regional Location Map




Figure 2- Aphrodite Tenement Map
