Ophara Cobalt Exploration Update

- Field work recommences to define new drill targets
- Ground inspection of historical aerial EM anomalies interpreted to be stronger sulphide conductors.
- Field and data review of Great Goulburn cobalt mineralisation trends and extensions.
- Aim to complete target definition in and around the Great Goulburn prospect in coming weeks for follow up drill testing of priority areas.

Summary

Alloy Resources Limited (ASX: **AYR**, **Alloy** or the **Company**) is pleased to advise of continued exploration at the Ophara Project located 50 kilometres west of Broken Hill in New South Wales.

Results from recent RC drilling and historical data compilation indicates the potential for widespread gold-cobalt mineralisation within the Great Goulbourn Project area.

The Company believes that the Great Goulburn Prospect has only advanced as a prospect because of some limited areas of outcrop of mineralisation that has been obvious to early explorers.




Figure 1 GEOTEM Channel 12 N shade Image with interpreted conductive units.

Field checking of GEOTEM anomalies (figure 1 below) is being pursued prior to any decision to complete new EM surveying. Satellite photography indicates that many of the interpreted anomalies are in largely unexplored areas and may be suitable for rock chip and/or soil sampling.

Following this field work the Company expects to be able to define priority targets for continued exploration, including RAB and RC drill testing.
