MOU WITH SOLARRESERVE

- **MOU to develop and construct a utility grade solar PV project in Australia with leading US based solar developer**

Decmil Group Limited (ASX: DCG) ("Decmil" or "Company") is pleased to announce that it has entered into a Memorandum of Understanding ("MOU") with an Australian subsidiary of leading US based solar developer SolarReserve ("SolarReserve").

SolarReserve is a leading global developer of utility-scale solar power projects with an extensive 13,000 megawatt ("MW") worldwide development portfolio of large-scale solar projects, including more than 3,400 MW of solar photovoltaic ("PV").

The MOU established between the parties relates to the development, design and construction of a ~70MW solar PV project in New South Wales and brings together SolarReserve's extensive experience as a power project developer, owner and operator with Decmil's reputation as a leading regional integrated engineering construction company.

Work on the development approval process is about to commence. Progression of the project is subject to successful completion of the development approval process and fund raising, with construction expected to commence in the 2018 calendar year.
