Orbital appoints new Director

Orbital Corporation Limited (ASX:OEC) ("Orbital" or "the Company") is pleased to advise the Company has appointed Mr Steve Gallagher as a non-executive director.

Mr Gallagher is currently a Principal at Agere Pty Ltd, an advisory and investment company, and has previously held Director positions with HKEX Hang Seng listed CCRTT, ASX listed ERG Ltd and Vix Technology Ltd where he was the founding CEO. Mr Gallagher also held GM positions with global engineering powerhouse Siemens in various business sectors including Industrial Automation, Building Technology and Power Systems.

Mr Gallagher holds a Bachelor of Engineering (hons) from the University of Melbourne and a Bachelor of Business from Monash University.

Commenting on the appointment, Orbital CEO and Managing Director Mr Terry Stinson said "Mr Gallagher's proven global track record in innovative technologies and product commercialisation and domestic and international company expansions will be highly applicable and a valuable addition to Orbital's next phase of growth".

The appointment of Mr Gallagher is part of a formal Board renewal process commenced by Orbital recognising the Company is entering a new phase of its business transformation with the pending establishment of manufacturing facilities in the United States and the progression of new business opportunities. As part of the Board renewal process Mr John Poynton AO has retired from the Board as a Non-Executive Director. Mr Poynton was appointed to the Board in March 2015 to assist with the restructuring of Orbital's business and to reposition the Company for future growth.

Chairman of Orbital, Mr John Welborn, credited Mr Poynton with reinventing Orbital's business model and vision: "John Poynton has been a huge supporter of management's efforts to commercialise both historic and new technologies for the creation of shareholder value.
