# Alliance Aviation Services Limited (ASX code: AQZ) ("Alliance")

### Alliance to Increase Regional Queensland and Wet Lease Services

Alliance today announces the expansion of its Regional Queensland operations following the execution of a Heads of Agreement with Virgin Australia. From 17 July 2017 Alliance Airlines will launch services on the following routes previously operated by Virgin Australia:

- Brisbane Bundaberg
- Brisbane Gladstone
- Brisbane Moranbah
- Brisbane Port Macquarie

These routes will be sold as Virgin Australia codeshare flights with full network connectivity and Velocity Frequent Flyer benefits.

Subject to consultation with Isaac Regional Council and BHP Billiton Mitsubishi Alliance (with respect to Moranbah only), Alliance Airlines plans to operate all four services using jet aircraft, which will substantially reduce travel times. The indicative flight schedule for the four routes appears below.

Any guests who have booked travel with Virgin Australia on the above routes from 17 July 2017 onwards will be re-accommodated on the Alliance Airlines services.

Additionally, Alliance Airlines will operate flights for Virgin Australia on the following routes on a wet lease basis for 12 months:

- Brisbane Cloncurry
- Brisbane Mt Isa
- Brisbane Rockhampton

Alliance Airlines will also continue to operate all Virgin Australia services on the Brisbane – Emerald route. All flights on these routes will be operated as Virgin Australia services.

The operation of the Regional Queensland and wet lease flights will require an additional three operational aircraft that have already been acquired from Austrian Airlines.

In aggregate the additional services announced above will increase the company's fleet by 11% and total flying activity by up to 45%.

The Heads of Agreement is subject to a number of commercial in confidence conditions precedent.

Alliance will announce its current full year financial results on 10<sup>th</sup> August 2017.
