Purported Notice to Requisition Meeting

Central Petroleum Limited ("**Central**") advises that it has received purported notices given under sections 203D, 249D and 249P of the *Corporations Act 2001* (Cth) ("**Corporations Act**") from shareholders claiming to hold 5.04% of Central shares requesting the Central directors convene a general meeting to vote on resolutions purportedly to replace three of Central's four directors, being Mr Robert Hubbard (chairman), Mr Wrixon Gasteen (non-executive director) and Prof Peter Moore (non-executive director), with the requisitioning shareholders' nominees, Mr Colin Goodall (as replacement chair), Mr Nick Bolkus and Mr Stuart Howes (as replacement non-executive directors). The list of shareholders that have requisitioned the general meeting, as provided to Central, is attached to this announcement.

Central's board is currently assessing whether the requisition has been made in compliance with the Corporations Act and Central's Constitution. If the notice given under section 249D of the Corporations Act is compliant and other requirements have been satisfied as required by law, the directors will undertake necessary steps to convene a general meeting in accordance with the Corporations Act and Central's Constitution.
