COMPLETION OF SHORTFALL

Odyssey Energy Limited (“**Odyssey**” or “**Company**”) is pleased to announce that the Company has completed the placement of the previously announced shortfall by issuing 12,582,500 at an issue price of \$0.05 each under the two for one renounceable entitlement offer.

In accordance with the terms of the Shortfall Offer, the Directors have exercised their discretion to offer the shortfall securities to nominated parties.
