- (a) \$3.50 million is a zero rate loan facility provided by Renaissance Assets Pty Ltd, a related party, with no fixed terms of repayment. No security was given.
- (b) \$1.964 million is a bank bill variable rate facility with a 3 year term expiring August 2018, provided by Bank of Queensland. Interest rates range from 4.95% - 5.20%. Loan is secured.
- (c) \$19.414 million is a mix of fixed and bank bill variable rate facilities with a 3 year term expiring October 2017, provided by Bank of Melbourne. Interest rates range from 4.69% - 5.62%. Loan is secured.
- (d) \$0.75 million is a commercial variable rate loan facility with a 20 year term, provided by ING Direct. Interest rates 4.34% plus a margin of 0.93%. Loan is secured.
