## Completion of the Recapitalisation and New Equity Securities Issued

Boart Longyear Limited (ASX:BLY) (Boart Longyear or the Company) is pleased to announce that it has raised a total of A\$5.692 million pursuant to the Share Purchase Plan (SPP) by issuing 284,600,000 new shares today at a price of A\$0.02 per share.

The completion of the SPP brings to a conclusion the Company's recapitalisation, as a result of which the Company's debt has been reduced, its liquidity improved and debt maturities extended. The Company has also issued a significant number of new shares and warrants.

In addition, Ascribe has elected to exercise on a cashless basis the 728,538,185 Class A 7% Warrants and 302,340,185 Class B 7% Warrants issued to it pursuant to the recapitalisation (being the entirety of its holding of Class A and Class B 7% Warrants) and as a result has been issued 799,853,908 shares today.
