# Retirement and appointment of Chairman

The Directors of Primary Health Care Limited ("Primary") regret to announce the retirement of the Chairman and independent Non-executive Director, Mr Rob Ferguson, due to unforseen family circumstances.

Rob has served as Chairman of Primary since his appointment on 1 July 2009. During that time he has guided Primary through a period of significant growth, including the opening of 23 medical centres, the commencement of Primary's IVF business and the creation of the Primary Health Care Training Institute.

Rob Ferguson will be succeeded by Mr Rob Hubbard who has been selected by the Board as the new Chair. Rob Hubbard was appointed as a Non-executive Director of Primary in December 2014 and became the Chairman of the Audit Committee and a member of the Risk Management Committee in February 2015. Rob has previously held various partnership positions in PricewaterhouseCoopers and acted as external auditor for some of Australia's largest ASX-listed companies. He is also a non-executive Director of Bendigo and Adelaide Bank Limited, Orocobre Limited and JK Tech Pty Ltd.

Commenting on the changes, Rob Hubbard said: "I would like to acknowledge Rob Ferguson's invaluable contribution to Primary over his years as Chairman. In more recent times, he has been pivotal in the selection of the executive team and the strategies which are now delivering a turnaround in our Medical Centres. Together with the rest of the Board and the management team, I wish Rob and his family all the best for the future.

"I am personally both excited and honoured to be taking over as Chair of this great company. I look forward to working with the other directors and the management team to ensure we deliver on our strategic vision for the benefit of all stakeholders."

Primary's Managing Director and CEO, Dr Malcolm Parmenter, added: "I am disappointed to see Rob Ferguson leave and I will miss his leadership, advice and guidance. However, I look forward to a strong and fruitful partnership with our new Chair at an important time for healthcare in this country. ## Appointment of Non-Executive Director
