
Placement of 6.8 million shares

Atlantic Gold wishes to announce placements totalling 6.8 million fully paid ordinary shares at 5 cents per share to raise \$340,000. The shares have been issued principally to existing company cornerstone shareholders without shareholder approval as provided under ASX Listing Rule 7.1.

If Atlantic Gold raises further capital within the next three months on less favourable terms to the Company, additional securities may be issued to these shareholders so that as far as practicable this placement is on substantially the same terms as any such capital raising. The shares issued pursuant to these placements will rank *pari passu* with existing issued shares at the end of the three month period.

The funds raised by the placements will provide short-term working capital while Atlantic Gold prepares to fund development of the Touquoy Gold Project and other promising gold targets in Nova Scotia.
