## ***Issue of Shares***

**Melbourne, Australia; 12 May 2015:**

LatAm Autos Limited (ASX:LAA), a leading online auto classifieds business in Latin America, today issued 1,209,235 ordinary shares to the Company's Chief Executive Officer, Jorge Mejia, in satisfaction of his A\$450,000 performance bonus associated with the company's successful IPO.

The shares were calculated at the 5-day VWAP ending on 8 May 2015. The performance bonus reflects Jorge's tireless efforts in the months leading up to the IPO, throughout which he recruited many of the company's key executives, attended investor roadshows, and begun laying the foundation for the LAA group across numerous countries, during which time he was not remunerated by the company.

The Board of Directors believe the performance bonus is an adequate reward for the contribution that Jorge made to the company's successful IPO. It also further aligns Jorge's interests to the future success of the group.

The Company has also issued 286,487 shares to the former Country Manager in Argentina. As detailed in the Company's announcement of 20<sup>th</sup> March 2015, these shares have been issued in satisfaction of part of his termination entitlements to a value of \$A106,000.


