ISSUE OF LATAM AUTOS PERFORMANCE RIGHTS

Melbourne, Australia; 29 July 2015:

LatAm Autos Limited (ASX:LAA) (**LatAm Autos** or **Company**), a leading online auto classifieds business in Latin America, today announced the issue of 3,700,004 Performance Rights to eligible employees of the Company in accordance with the LAA Equity Incentive Plan which was approved by shareholders on 8 May 2015.

The grant of Performance Rights is a long term incentive intended to align the interests of employees with other owners of the Company.

Upon vesting, each Performance Right entitles the holder to receive one ordinary share in the Company at no cost to the employee.

The number of Performance Rights that will vest is contingent on the Company's total shareholder return (**TSR**) relative to comparable companies over a designated period, which is currently the period from the Company's ASX Listing date of 17 December 2014 to 31 December 2018. Vesting is also subject to the continued employment of the employee. The Performance Rights expire on 30 January 2019, unless they lapse earlier.

An Appendix 3B is attached containing the details of the recent changes to the securities on issue.
