Any DRP elections made by eligible investors must be received by the registrar, Link Market Services, by 06 January 2020. For DRP participants, any distributions will be reinvested in units in accordance with the DRP terms and conditions, which can be obtained by calling Link Market Services on 1300 420 094.
