No. During the March 2020 quarter, the Company paid \$297k to acquire four new leases (one-off) and \$837k in annual lease fees (US\$3/acre) to hold the 195,373 acres through to March 2021. All lease fees are now paid until renewal in March 2021 and the Company is not expecting any material lease costs in the next three quarters.
