

## Amended Appendix 3X and Form 603

Silk Logistics Holdings Limited (**SLH** or **Company**) wishes to advise that, due to an inadvertent notification oversight as part of the IPO participation, the Appendix 3X Initial Director's Notice and Form 603 Notice of Initial Substantial Holder, for John Sood lodged on 9 July 2021 understated the number of shares in the Company in which John Sood has an interest.

Please find attached an amended Appendix 3X Initial Director's Interest Notice and Form 603 Notice of Initial Substantial Holder (**Amended Documents**), which replace the respective lodgments on 9 July 2021 for Mr John Sood.

In relation to the Amended Documents, the Company advises as follows:

2. The initial Appendix 3X and Form 603 were incorrect due to inadvertent notification oversight as part of the IPO participation.
3. Once the errors were discovered, the Company took immediate steps to correct and lodge the Amended Documents attached.
4. The Company takes compliance with the Corporations Act and ASX Listing Rules seriously, including to ensure that its Directors are aware of the Company's disclosure obligations under Listing Ruling 3.19A and otherwise considers that its current arrangements are adequate to ensure compliance with Listing Rule 3.19B.
