FY20 and FY21 LTIP Issuance

rhipe Limited (ASX:RHP) (*rhipe* or the *Company*) refers to its announcement today that the scheme of arrangement under which Crayon Software Experts Australia Pty Ltd, an indirectly wholly-owned subsidiary of Crayon Group Holding ASA (*'Crayon'*) (*'Scheme'*) is now legally effective.
