## FINANCE FACILITY UPDATE

Terramin Australia Limited (ASX: TZN) (**Terramin** or the **Company**) is pleased to announce that the Company and its wholly owned subsidiary, Terramin Exploration Pty Ltd (**TEX**), have entered into an agreement with major shareholder Asipac Group Pty Ltd (**Asipac**) to extend the term of its existing Short-Term Standby and Bird in Hand Loan Facilities to 31 January 2025 on the same terms.
