### Medlab Company Update

The Company is in continued discussions to obtain a business, to re-purpose the MDC ASX corporate listing, and to seek ASX approval for re-listing in due course. The Company expects that the re-compliance process can begin subsequent to this transaction.

### Key Financial Highlights
