

Virgin Money UK PLC to be removed from the S&P/ASX 200 Index

SYDNEY, SEPTEMBER 18, 2024: S&P Dow Jones Indices announced today that it will remove Virgin Money UK PLC (XASX: VUK) from the S&P/ASX 200 Index, whereby the company will be acquired by Nationwide Building Society.

S&P Dow Jones Indices will remove Virgin Money UK PLC from the S&P/ASX 200 effective prior to the open of trading on Thursday, September 26, 2024. Virgin Money UK PLC will be replaced by Codan Limited (XASX: CDA), in the S&P/ASX 200 effective prior to the open of trading on Thursday, September 26, 2024.
