### **NEW CEO TO ATTEND MAJOR FINTECH CONFERENCE AND EXPEDITE US MARKET ENTRY**

Greg Woszczalski and I look forward to attending Money 20/20 alongside Simon as OVT endeavours to establish a presence in the US market."
